### Call to Order

Steve opened the meeting at 6:00. He asked that members to keep extra conversations to a minimum as the acoustics in the room make it difficult to hear.

### Minutes

Virginia moved and Mary Ann seconded that the minutes of the May 11<sup>th</sup> meeting be approved as sent. The motion passed.

### Financial Report

Virginia reported that the club has an account balance of \$6252.54. She has received 34 registrations for the car show.

### Old Business

Steve asked if anyone else needed staff T-shirts. He said Tana will order about 75 car show T-shirts.

**Car Show:** Arlan reported that 2 sponsors have now paid – Joe Horst and Jimmy Richardson. He said he will go to State Farm to get donations for our goody bags. We will use the trophies we purchased last year and have the information updated. We need to add a “Grand” and “First” also. We will also have bottled water available which he will take care of. Arlan will also do an interview about the car show on the radio.

Deb Rife said there will be a fireman’s breakfast on Saturday and transportation available.

Arlan said he will need 4 or 5 volunteers on Friday the 16<sup>th</sup> to put up “no parking” signs and barriers, and take them down. He also needs volunteers to direct parking for the show cars on Saturday. John

added that we will need to have a work party the Saturday before the show to stuff goody bags and get the signs ready. We will finalize a list of volunteers at our next meeting.

Cindy asked for approximate numbers of attendees in order to place orders for food with Dusty Spur. She also requested that we give Dusty Spur an advance to help with their costs. John moved and Matt seconded a motion to pay Dusty Spur \$1000 as an advance. The motion passed. Cindy also asked about meal tickets for Friday night – apparently we have some old ones we can use.

Dixie reported that she and Ed have found that many businesses are willing to donate raffle items even though they were told that we would purchase them this year. They will have donations and/or purchases from about 15 businesses. They will also purchase sixteen \$25.00 gas cards to exchange if needed. Dixie added that Wallowa Lake tram owners will donate two tickets.

Arlan reported that Frank Carlson will perform at the car show, Deb Rife will do the Cruise for Cash, and he will take care of the poker cruise. Cindy will arrange for coffee and donuts on Sunday. Arlan added that 12 local restaurants will participate in our Saturday dinner voucher program. There will be 2 vouchers included in the registration fee. He has been putting up posters around town. It was mentioned that ODOT will donate some items for the goody bags and, also, John Howard usually donates items.

Mary Ann asked for judges for the car show and Jim Coxen was volunteered. Thanks, Jim.

Dixie will also need volunteers for the raffle items. Several volunteered.

Steve read the list of upcoming car shows from last month's minutes. He said that the one in Ione on July 4<sup>th</sup> is especially fun. There is no entry fee, no trophies, but they have an artwork auction and a street dance. There was some discussion about shows that only award trophies to car club members.

### **New Business**

Jim asked if anyone would be interested in having a yard sale for car parts. There is some interest and Steve said we can discuss it further after the car show.

Steve will send out an email about the Imbler 4<sup>th</sup> of July parade. Everyone agreed that their parade is great.
